The College need to appoint eight(08) Assistant Professor in Commerce & Mgt on regular basis since the college is getting resource person as a temporary arrangement so college must appoint eight full time resource persons.
2.	<b>BCA I,II (one unit)</b>	1.The college is required to spent an approximate amount of Rs.1,50,000/-). on books. 2.The college has 100% deficiency in terms of the staff. The college is required to appoint (03) Astd. Professor on regular posts (01) for existing BCA I & (02) for BCA-II.



The college is required to spend and approximate amount of Rs. 75,000/- on books and Rs. 25,000/- on journals. 2. The college has 36% deficiency in term of staff. The college is required to appoint nine Assistant Professors with teaching load of 16 periods per week required for commerce. 3. The college has no infrastructure in term of classroom/ laboratories/equipments. Tally software, SPSS Software may be procured. The infrastructure is under development. 4. The college has 10% deficiency in term of infrastructure. Tally software, SPSS Software (licence) may be purchased, Two LCD projectors, Smart podium also purchased.
5.	B.C.A.-I ( one unit)	1. To start new course the college is required to spend an approximate amount of Rs. 10,000/- on purchase of books. 2. The college is required to appoint one teacher and one Technical lab Assistant.


